Deposits are \$300 per person for most of the tours. Balance is usually due 90 days before departure.

**Policies, General Information, Terms and Conditions, and Release of all claims**

**Reservations:** We require that you complete and sign our Registration Form and return it to us along with a deposit of \$300 CAD per person for land tours. If registering by phone or email, your deposit must be received within 14 days or the space will be released. Typically, invoices confirming a tour for the balance due will be mailed approximately 120 days prior to departure and payment is due 90 days prior to departure.

**Cancellation & Refund Policy:** Notification of cancellation must be received in writing. Unless otherwise noted, the following policy applies: if cancellation is received up to 120 days prior to departure, full deposit and any payment, less a \$100 CAD will be refunded. If cancellation is received between 60 and 119 days prior to departure, 50% of the tour fee is not refundable. Thereafter, all deposits and payments are not refunded. Refunds cannot be made to participants who do not complete the tour for any reason.

Satipo Tours has the authority to disqualify any participant, without refund or further obligation, if they do not follow the recommendations of the leader or if the tour leader feels that the individual's continued participation will jeopardize the wellbeing or enjoyment of the individual or group.

**Trip Insurance:** We strongly recommend that you purchase trip cancellation insurance in case of injury, illness or some other unexpected event which forces you to cancel. It is also recommended that emergency medical insurance be obtained covering expenses resulting from accidental injury or illness during the tour.

**Medical Information:** Participation on a Satipo Tour requires that you are in good health, able to complete easy walks of a couple hours duration and meet the tour's schedule. Persons with medical problems or dietary restrictions must make them known to us well in advance of the tour. Satipo Tours has no special expertise as to what illness or diseases might be present and strongly recommend you consult your doctor and or Travel Immunization Clinic before you go. It is your responsibility to get immunizations to protect you from diseases or illness that may exist in the places you will be visiting on tour.

**Tour Fees:** Every effort will be made to charge the prices quoted or detailed itineraries, but currency fluctuations may force us to change tour prices at any time before departure. Current prices are listed on our website and reflect payment by cash/cheque. Prices for payment by credit card are higher. Fees are per person, based upon double occupancy.

Single rooms, when available, will be provided upon request for an additional fee. For participants traveling alone but wishing to share a room, we will arrange for a roommate, if possible. If a roommate is not available, the single supplement will be charged.

Tour fees include all lodging, meals, ground transportation, in-country air transportation, guide services, and park and special entrance fees. The tour fee does not include alcoholic beverages, transportation to or from the tour departure or conclusion points, passport or visa fees, entry or exit fees, airport taxes, phone calls, laundry, or other items of a personal nature. We reserve the right to remove you from a tour if you have not made full payment by the due date.

**ACKNOWLEDGEMENT OF RISK, RELEASE & INDEMNITY**

In connection with my enrolment in a Thomas Plath Environmental Services trip and any transfer of this reservation to another trip, including any pre-trip and post-trip extensions in which I participate, (collectively defined as the 'Trip'):

**Risks**

I acknowledge that: Trips with Thomas Plath Environmental Services (hereinafter 'Thomas Plath Environmental Services', which term includes Thomas Plath Environmental Services related and affiliated companies and their employees, guides, shareholders, officers, directors and agents) are intentionally designed to take clients 'off the beaten path', to places where facilities, infrastructure, and safety and other standards may not be sophisticated and may be different from those in my country. Trips involve physical activity that can be demanding depending on the condition of the traveller and the risk of serious personal injury including permanent disability and death from accident, illness or the actions of other persons. Medical facilities and services may not be easily accessible and may not be sophisticated. There are also risks associated with the Trips such as theft or loss of or damage to property. Some of the services provided in connection with the Trips, including lodging, transportation, food service and local tours and activities, are obtained from independent suppliers over whom Thomas Plath Environmental Services has no control.

**Limitation of Liability and Release**

I understand and have carefully considered the risks involved in taking a trip of this nature. I accept those risks and assume full responsibility for any loss, injury or damage to me, my family or my dependants arising in connection with my participation, or the participation of members of my family, in the Trip. We have our own insurance appropriate to our needs in respect of such loss, injury or damage.

I accept that although Thomas Plath Environmental Services endeavours to choose appropriate independent suppliers to provide services on the Trip, Thomas Plath Environmental Services has no right to control their operations and therefore makes travel arrangements for the Trip on the condition that Thomas Plath Environmental Services will not be liable for any negligent or wilful act or omission of any independent supplier, or any other unrelated third party. I acknowledge that the services provided by the independent suppliers are subject to the laws of the place where the services are provided, and any conditions imposed by those suppliers. The liability of the independent suppliers may be limited by their tariffs, conditions of carriage, tickets or vouchers or international conventions or agreements.

I acknowledge that the cost of the Thomas Plath Environmental Services Trip is based on my executing this Acknowledgement of Risk, Release and Indemnity. In consideration for Thomas Plath Environmental Services accepting me on this Trip I agree that I will not sue Thomas Plath Environmental, in respect of, and I hereby forever release Thomas Plath Environmental Services from, all liability for economic loss and physical or mental injury, direct or indirect, arising in connection with the Trip—including without limitation permanent disability or death; any emotional distress; any loss of services, financial support, aid consortium or companionship; and any damage to or loss of property—in each case, even if caused, in whole or in part, by the conduct, including the negligence, of Thomas Plath Environmental Services ; except where such loss, injury or damage is caused by reckless or fraudulent conduct on the part of Thomas Plath Environmental. or their employees, guides, shareholders, officers or directors, in which case I may sue only Thomas Plath Environmental Services in respect of that conduct.

I further agree that I will indemnify Thomas Plath Environmental Services in respect of any claims for loss, injury or damage made by: i) my family members, dependants or heirs, or ii) third parties, which I, my estate, my family members or dependants have sued if damages are recovered from such third parties to the extent the third party claims and obtains complete or partial indemnification from Thomas Plath Environmental; except where the loss, injury or damage is caused by the reckless or fraudulent conduct on the part of Opem Doors. or their employees, guides, shareholders, officers or directors.

I acknowledge that I have read and accept the further terms and conditions set out in the Thomas Plath Environmental Servicestrip planner. I acknowledge that Thomas Plath Environmental Services reserves the right to decline accepting or retaining any traveller whose health or actions, in 'Thomas Plath Environmental Services sole judgment, impede the operation of a trip or the welfare or enjoyment of fellow travellers.

I agree that Thomas Plath Environmental Services is the trustee of the respective rights of Thomas Plath Environmental Services under this agreement.
